Specialty Copay Assistance Program Effective January 1, 2020

What is a Specialty Drug?

Specialty drugs or **specialty** pharmaceuticals are a recent designation of pharmaceuticals that are classified as high-cost, high complexity and/or high touch. **Specialty drugs** are often biologics—"**drugs** derived from living cells" that are injectable or infused (although some are oral medications).

What Specialty pharmacy does Express Scripts use?

Accredo is the Express Scripts Specialty Pharmacy

Can I continue to use my local pharmacy for nonspecialty medications?

YES! The current benefit for non-specialty medications will not be impacted. Therefore, you will still be able to use pharmacies such as Walgreens, CVS, Walmart, etc. for medications that are not designated as Specialty medications

Will my copay apply to my deductible and out of pocket accumulator?

YES! The final copay (your actual cost) will be applied to your deductible and OOP. However, any monies, paid by the manufacturer, will not be applied to your accumulator. This amount will be adjusted by Express Scripts within 24-48 hours after the claim processes.

Is insulin (Humalog) considered a Specialty drug?

Although insulin meets many of the criteria designating a drug as a specialty medication, it is **NOT** a classified as a specialty drug.

Dear Ken,

Based on our records you have recently filled a specialty prescription. Specialty drugs can often cost thousands of dollars per month and typically have special handling or administration requirements. To offset the high cost of specialty drugs, most manufacturers offer copay assistance programs.

We encourage you to take advantage of the copay offered by the drug manufacturers which will mitigate costs for both you and Hudson Valley Credit Union. NFP Rx Solutions will provide you with support in accessing the copay assistance programs that are available for your medication.

In order to take advantage of the programs, effective January 1, 2020, your copay will be 20% of the price on specialty prescriptions. While this change may significantly increase your copay, the manufacturer copay assistance will cover most, if not all, of your out-of-pocket expenses for your specialty medication*. As a result, your out-of-pocket costs for a 30-day supply will in most cases be less than what you are paying today.

Please contact Rx Solutions prior to filling your next specialty prescription to enroll in the copay assistance program and start saving on your specialty prescription.

Important Specialty Pharmacy Changes

SPECIALTY CO-PAY ASSISTANCE PROGRAM

Specialty drugs can often cost thousands of dollars per month and typically have special handling or administration requirements. To offset the high cost of specialty drugs, effective January 1, 2020, Hudson Valley Credit Union will offer a co-pay assistance program to mutually benefit you and Hudson Valley Credit Union.

If you are taking specialty drugs for conditions such as rheumatoid arthritis, multiple sclerosis, HIV, and cancer - then you could be eligible for co-pay assistance, and notified by an NFP Rx Solutions Pharmacist via letter to register for the program.

- Your co-pay will be 20% of the price on specialty prescriptions
- If no coupon is available, your co-pay will not exceed the highest co-pay under your plan
- This program provides access to manufacturer copay programs, where eligible, to offset Out-of-Pocket costs for your specialty medications
- Members should contact NFP Rx Solutions at 888-201-9175 to enroll in the available programs through the medication's manufacturer





HUMIRA EXAMPLE: OLD PROCESS VERSUS NEW PROCESS



- 1. Participant is issued Specialty Prescription
- 2. Participant called CVS/Caremark Specialty (Mandatory)
- 3. Participant walks through set up with counselor
- 4. Participant is billed up to \$100 co-pay
- **5.** Participant is mailed specialty medication
- 6. Hudson Valley Credit Union pays the remaining \$4,900.00



- 1. Participant is issued Specialty Prescription
- 2. Participant calls CVS/Caremark Specialty 800# (Mandatory)
- 3. Contact Rx Solutions for copay assistance at 888-201-9175
- 4. Pharmacist determines coupon eligibility = YES or NO

NO COUPON

- **5.** Participant is billed 20%, not to exceed max co-pay
- **6.** Participant is mailed specialty medication
- **7.** HVCU pays the remainder

WITH COUPON

- 5. Participant is billed a 20% co-pay that will be mostly covered by the coupon, not to exceed maximum copay
- **6.** Participant is mailed specialty medication
- 7. HVCU pays \$4,000 Manufacturer covers \$980
