# IMPORTANT CONVERSION WEEKEND DETAILS

HVCU and Berkshire Bank are working closely together to make sure you have access to your new HVCU account(s) and funds as quickly as possible during conversion weekend. As previously noted, please be sure to visit hvcu.org/WelcomeBerkshire for regular updates about the weekend timeline and for additional information on these topics.

### ACCESSING FUNDS AND DEBIT CARD USE **DURING CONVERSION WEEKEND**

- HVCU will use your Berkshire Bank account balance(s) as of 5PM ET on Friday, September 27, 2024 to fund your new HVCU account(s) by 7PM ET on Saturday, September 28, 2024. We anticipate you will have full access to your accounts at that time.
- If you have a Berkshire Bank Debit Card, a temporary credit of \$500 will be available in the primary checking account and savings account linked to the card by approximately 5PM ET on Friday, September 27, 2024. Once your new HVCU Visa Debit Card is activated, and this credit is available, you can use it for point-of-sale transactions and to access your funds at ATMs. Use the branch/ATM locator on our website at hvcu.org/locations to see where you can get cash surcharge-free.


Berkshire Bank's online services will no longer be available beginning Friday, September 27, 2024, at 5PM ET. We have included important details about the online services transition below as well as in our Member Checklist included on page 10 of this guide.

## ACCESSING ONLINE SERVICES AT HVCU

Manage your day-to-day finances with our user-friendly online banking tools. You'll have the freedom to do your banking safely and conveniently when and where you want with our Internet Banking and Mobile Banking services.

You can log into HVCU's online services beginning Monday, September 30, 2024. Visit hvcu.org to log into Internet Banking or download our Mobile App from the Apple App Store or Google Play. To log into online services for the first time, you will need your Berkshire Bank username and will be prompted to change your password. Both Internet and Mobile Banking use the same username and password to login, so you can use either system, or both - the choice is yours.





- Q: What is the cutoff date for scheduling Bill Payments through Berkshire Bank's Bill Pay Center?
- A: There will be no access to Berkshire Bank's Bill Pay Center after 3PM ET, Friday, September 27, 2024. However, it is highly recommended you discontinue using Berkshire Bank's Bill Pay Center immediately and make alternative arrangements until enrolled in HVCU's Bill Pay service post the conversion. If a Berkshire Bank bill payment is presented after September 27, 2024, it will be honored for up to 60 days.
- Q: When can I enroll in Hudson Valley Credit Union's Bill Pay service?
- A: Bill Pay will be available for enrollment after the conversion is complete. Visit hvcu.org/WelcomeBerkshire for an update on availability. We recommend you download/print your Berkshire Bank bill pay history for future reference, and take note of your current payees, billing information, and recurring payments so that you can set up your bill payments again once you have enrolled in Hudson Valley Credit Union's bill pay service.

### Q: What do I do if I have eBills established through Berkshire Bank's Bill Pay Center?

### Q: What do I need to do if I am currently using an account aggregator with Berkshire Bank's Bill Pay Center?

A: If you added outside accounts to your online banking so you can see an all-in-one snapshot (other financial username and password in order to add HVCU into the account aggregator service.

## ADDITIONAL ONLINE SERVICES TO UPDATE



#### **Card Management & Rewards**

Enable card controls to block and unblock transactions on your HVCU Visa Debit Card, and access reward points earned for qualifying debit card transactions.



### **Mobile Wallet**

Add your new HVCU Visa Debit Card to mobile wallets to make purchases conveniently through mobile apps and virtually anywhere you can swipe or tap your card.



#### Quicken/QuickBooks

If you are an existing Quicken user, you should download your current Berkshire Bank data before 5PM ET on Friday, September 27, 2024. On or after Monday, September 30, 2024, you will need to activate Hudson Valley Credit Union as your new financial institution.

A: In order for future eBill payments to be processed, it is imperative that you unenroll in eBills with Berkshire Bank's Bill Pay Center as soon as possible. If you fail to take action and do not unenroll in eBills in a timely manner, it could take up to 60 days to reestablish your eBills. You will need to schedule one-time payments to make any payments

institutions, retirement/pension accounts, etc.), these will need to be reestablished. If you use another aggregator service, your new HVCU accounts will need to be added in place of Berkshire Bank accounts once you have access to HVCU's Internet Banking or Mobile Banking services. #### eStatements

Download/archive your Berkshire Bank eStatements to ensure you have access to historical account history. Once registered for Internet Banking or Mobile Banking at HVCU, you may enroll in eStatements.





#### **External Accounts**

Take note of any external accounts (including loans) you have set up at Berkshire Bank, as the accounts and any recurring transfers associated with the accounts will need to be reestablished.

#### **P2P Payments**

Keep a record of recipient information and any recurring transfers set up in Berkshire Bank's P2P Payments service so those payments can be reestablished through HVCU's HV\$end service.

### **OVERDRAFT ELECTIONS AT BERKSHIRE BANK**

If you have designated sources of overdraft protection for your existing Berkshire Bank consumer or business checking account(s), HVCU will honor those elections as part of the conversion of your accounts.

## **HVCU OVERDRAFT OPTIONS**

If you would like to learn more about HVCU's overdraft services or change your elections, we would be happy to review this with you once the conversion is complete. In addition to a savings account, we offer line of credit solutions that can be used as overdraft sources. You'll need to apply for a line of credit if you do not already have one.

## **HVCU PRIVILEGE PAY**

If you do not have Courtesy Pay on your Berkshire Bank checking account(s), you will be automatically opted in to Privilege Pay on your new HVCU checking account if you meet our standard qualifications. This service prevents your checks and ACH debits from being declined when you unintentionally overdraft and have insufficient funds in your checking or other overdraft sources. Please contact HVCU after the conversion if you would also like to have Privilege Pay protection for your Debit Card transactions. Privilege Pay creates a negative balance in your account, and HVCU gives you 30 days to repay that balance.

HVCU pays each item on one personal checking account up to a \$500 limit inclusive of fees. The fee charged for a Privilege Pay item is noted on our Fee Schedule for Personal Accounts.

Please note: If you had Courtesy Pay at Berkshire Bank, HVCU will honor the \$750 limit you are accustomed to when this service transitions to our Personal Privilege Pay solution.

For additional terms and conditions of Overdraft Protection and Privilege Pay, please refer to our Truth in Savings Disclosure & Account Agreement.

#### **Business Privilege Pay**

HVCU pays each item on one business checking account up to \$1,500 in total items, including any Business Privilege Pay item fees. The fee charged for a Privilege Pay item is noted in our Fee Schedule for Business Accounts.

For additional terms and conditions of Overdraft Protection and Privilege Pay, please refer to our **Business Account Agreement.** 

As noted in the Welcome Guide previously sent to you, you will receive two statements showing your September account activity. The first will come from Berkshire Bank reflecting account activity through September 27, 2024. A second statement will be sent by HVCU in the beginning of October reflecting activity of your account(s) from post conversion through September 30, 2024. Unlike Berkshire Bank, HVCU will consolidate all of your accounts into one statement. If you enroll in eStatements, you will receive an email notification that your statement is ready for viewing in Internet Banking and Mobile Banking.

As noted on Page 5, if you have a Berkshire Bank Debit Card, a temporary credit of \$500 will be deposited into the primary checking and savings account associated with the card on Friday evening, September 27, 2024. HVCU hopes this convenience will help make for a smoother transition for you during conversion weekend. This temporary credit will then be reversed once the funds from your Berkshire Bank account(s) have moved to your new HVCU account(s). You will see this reflected on the first statement you receive from HVCU in October.


